Attached is the form necessary to apply for admission to practice in the United States District Court for the Eastern District of North Carolina. After the form and the \$180.00 fee are submitted to the Clerk's Office, you may sign pleadings and file them with this Court. However, to complete the admission process, it is each attorney's responsibility to schedule an appointment to take the oath before a district judge, bankruptcy judge or magistrate judge. The attorney usually takes the oath in open Court or in the Chambers of a judge by prior arrangement. You may appear in Court after you have taken the oath.

If you are previously admitted to the U.S. District Court for the Middle or Western Districts of North Carolina, you may be admitted to the bar of this Court upon tendering the application and \$180.00 fee, together with a copy of the certificate or order of admission, or a *current (within 6 months)* certificate of good standing issued by the other district, without the necessity of taking the oath here in the Eastern District.
