Accessing and Viewing Final Presentence Reports filed in CM/ECF

Introduction	When a final Presentence Report (PSR) is filed for a particular defendant in CM/ECF, all counsel of record will receive the Notice of Electronic Filing (NEF) but the attorney(s) of record for that defendant will be able to access the PSR through the link in the NEF if:
	 The attorney is an active electronic filer in the EDNC The attorney has electronically filed a Notice of Appearance for the defendant The attorney was granted access to the PSR when the US Probation Office filed the PSR in CM/ECF The easiest way for an attorney to view the PSR is through the document link in the NEF. The first view of the PSR through the NEF is free. The free
	look expires after fourteen (14) days. The attorney will be assessed PACER fees for subsequent views of the PSR or after the free-look expires. If the attorney accidentally deletes the NEF, or the document link in the NEF no longer works, the attorney can still view the PSR by logging into CM/ECF and <u>then</u> PACER to view the docket sheet.
